We are pleased to inform all maritime carriers, air carriers and road carriers, other persons involved in transport, whether for goods in transit or for entry / exit from the territory of the Central African Republic, that the Government of the Central African Republic has, on May 09, 2023, designated the company "**SAIGE RCA SARL**", address "**BP2804 Bangui Centrafrique**", as a representative for the issuance of the Shipowners' Commission covering global loading points (Europe, Americas, Africa, Middle East, Oceania, Australia, Asia).

As a follow-up to the contract signed between K-POLYGONE CA INC and "**SAIGE RCA SARL**" relating to the representation of the CAR with shipowners, shippers, charterers, port, airport and border authorities, I authorize you to start launching your activities on September 1, 2023.

The required documents, you must provide to the authorized port agents K-POLYGONE SAS at the port of loading for the issuance of the Cargo Commiaassion certificate as follows:

1. bill of lading
2. Commercial invoice
3. Cargo manifest

**Rates**

Transport companies must ensure that the freight commission is paid to K-POLYGONE duly authorized to comply with the procedure in the ports of loading abroad, for the discharge in the Central African Republic.

**Sanctions**
